### **Detail of Various Student Welfare Scholarships/Freeships**

#### Scholarships Funded by the State/Central Govt .:

#### SC/ST/OBC Scholarships:

The students who belong to SC, ST or any other reserved category are recommended to be charged a fee as per the government rules.

### Post-Matric Scholarship Scheme for SC and BC Students:

**Introduction:** The objective of the scheme is to appreciably increase the Gross Enrollment Ratio (GER) of SC and BC students in higher education and to assist them by providing financial assistance at post-matriculation or post-secondary stage so that they are able to complete their education.

Eligibility: 1. The student must be a resident of Punjab.

2. If the student belongs to SC category, the annual income of parents/guardians from all sources should not exceed Rs.2.5lakh.

3. For BC/OBC students, the limit should not exceed Rs. I lakh.



## Post-Matric and Merit-cum-Means Scholarship Scheme for Minorities:

**Introduction:** Muslims, Sikhs, Christians, Buddhists, Jain and Zoroastrians (Parsis) have been notified as minority communities under Section 2 (c) of the National Commission for Minorities Act,1992. The objective of the scheme is to award scholarships to meritorious students belonging to economically weaker sections of these communities as to provide them better opportunities.

Eligibility: Scholarship will be awarded to the students who have secured not less than 50% marks or equivalent grade in the previous final examination and the annual income of whose parents/guardians from all sources does not exceed Rş.2.00 lakh (2.5 lac for Merit-cum-Means based).

Funding Agency: Ministry of Minority Affairs.

#### Fee Concession Policy by the institution:

- The Managing Committee of the college provides fee concession to the students belonging to the economical weaker sections and to the students who excel in academics, sports and various kinds of cultural activities.
- If a student secures more than 95% marks in 10+2 class, she is exempted of full fee.
- If she secures more than 90% and less than 95%, she is given the concession of Rs. 7000/-.
- If she secures more than 85% and less than 90%, she is given the concession of Rs. 5000/-.
- If she secures more than 80% and less than 85%, she is given the concession of Rs. 3000/-.
- If a student pays full fee at a time, she is given concession of 5%.
- If our pass-out student gets enrolled in Masters Degree Course, she is given the concession of Rs. 3000/-.
- Under the *Financial Assistance/Mentor Scheme* initiated by the managing committee, the brave-heart visionaries from home and abroad assist in monetary terms the poor and the deprived students.
